For the period from the Inception Date, until 6/11/2001, values assume that the NYLIAC Pinnacle VUL and NYLIAC Pinnacle SVUL policies were available, which they were not. NYLIAC Pinnacle VUL and NYLIAC Pinnacle SVUL are no longer being offered for sale.
